

Feedback Report 2017-18

Cot - I

On the basis of analysis made by feedback committee on the 10-11-2018 following conclusions were drawn which were summerized and forwarded to the Principal for consideration-

- 1- Teachers are highly satisfied with the process of college sanctioning leaves, co-ordination between teachers and college administration and particulars being made available by the college. Satisfactory rating is provided to infrastructure of the college, facilities provided for professional growth and for smooth running of the college. However, teachers are bit unsatisfactory towards the facilities provided to them like crèche, health insurance and proper utilisation of teachers' welfare fund.
- 2- Mandey teachers, as well, are highly satisfied with smooth sanctioning of leaves, opportunities provided for professional growth, working smooth conditions prevailing in college. Satisfactory level is indicated for co-ordination between teachers and college as well as for infrastructure of the college. Again mandey teachers are also unsatisfied towards the facilities being provided to them by college. This is the aspect where college administration needs to work out on.
- 3- Similarly the non-teaching staff also have almost the same levels of assessment, where they provide, highly satisfied score to smooth sanctioning of leaves, co-ordination between staff and administration, infrastructure of college and smooth working conditions. They are satisfied to opportunities being provided for professional growth but again unsatisfied to the facilities being provided to them by college.

As such the only unsatisfactory level to all the teaching and non-teaching staff is the facilities being provided to them by the college where the administration needs to put in more efforts.

PG and UG students feedback about college :-

The students are highly satisfied for the parking facilities provided to them, discipline, availability of girls common room, availability of principal, drinking water facility, Principal's behaviour and communication, Principal as guardian, Library and reading room facility, sports, scholarship, drinking water facility, hygienic toilets, book bank and financial aid to weaker section of students.

Students are satisfied to the cultural activities, internet facilities, functioning of career council cell, prior information of important messages, effectiveness of anti-ragging cell, first aid facility, remedial classes, campus placements and condition of laboratories in the college.

However the students seemed to be unsatisfied over the absence of canteen facility, academic tours and camps being held to negligible and highly unsatisfied towards the effectiveness of NCC, NSS, Rovers and Rangers.

Feedback by the Guardians of UG and PG Students :-

The Guardians are satisfied with all the parameters like that of infrastructure of college, academic environment, availability of girl's common room, parking facility, student's uniform, discipline, suitable college timings, library, qualified staff, scholarship, ragging free environment, staff's behaviour, easy exit in emergency, environmental awareness programmes, first aid, extra co-curricular activities, safety measures, frequent communication between parents and teachers, job oriented courses, remedial classes, sports, laboratories and functioning of placement cell.

Guardians are however unsatisfied with the functioning of NCC, NSS, Rovers and Rangers.

On the whole teaching and non-teaching staff are unsatisfied with the facilities being provided like that of crèche, health insurance policies and proper utilisation of welfare fund. While the students as well as their guardians are unsatisfied with the functioning of NCC, NSS, Rovers and Rangers in the college. This is where the college and administration needs to focus on.
