# Memorandum of Understanding (MOU)

This Memorandum of Understanding (MOU) is executed on 19 May 2022

Between

**J V Jain (PG) College Saharanpur, Uttar Pradesh India 247001**, and also  
individually referred to as **Party I**,

And

**College of Engineering Roorkee (COER) & University of Engineering and  
Technology Roorkee (UETR)** also referred to as **Party II**.

WHEREAS, J V Jain College Saharanpur, established in 1955 under the Society Registration Act 1860, hailing its campus at Pradumna Nagar, Saharanpur, equipping students with Graduation and Post-Graduation in Science, Commerce & Arts Streams.

WHEREAS, COER and UETR is committed with the responsibility of imparting quality education in Engineering and Sciences, Business Management, Computer Application, Agriculture etc. to young professionals and in moulding them into competent, well trained technical manpower.

NOW THEREFORE, both parties now

- Appreciating the need for creation of large reservoir of highly qualified manpower in these fields.
- Desiring to enhance their efforts by joining their expertise and resources.

## 1. SCOPE OF THE MOU

This MoU details the modalities and general conditions regarding collaboration between both parties for enhancing the availability of highly qualified manpower in mutually agreed areas of education and research without any prejudice to prevailing Rules and Regulations in J V Jain College Saharanpur and COER & UETR. The areas of cooperation can be extended through mutual consent.

## 2. SCOPE OF ACADEMIC INTERACTION

- Academic and Research collaborations in areas of mutual interest
- Exchange of academic information and scholarly information materials, and publications
- Participation of faculty members in delivering lectures in virtual and offline mode to faculty and students of both colleges/Institutes on mutual agreed terms.
- Exchange of student and faculty

- Organization of joint conferences, workshops.
- Internship of selected students
- The Parties shall mutually contribute and take part in any and all phases of the planning and development to the fullest extent possible.

### 3. CO-ORDINATION OF THE PROGRAMME INCLUDING FINANCIAL ARRANGEMENTS

1. The activity under this MoU between both parties will be coordinated by a coordinator from each organization.
2. Financial arrangements for each specific activity will be decided on a case-to-case basis as required, subject to approval by each organization.
3. This MOU is not intended to create any rights, benefits, and/or trust responsibilities by or between the Parties.

### 4. TERM

This Agreement shall commence upon the Effective Date, as stated above, and will continue until Two Years.

- **Termination.** This Agreement may be terminated at any time by either Party upon 15 days written notice to the other Party.
- **Indemnity.** The Parties each agree to indemnify and hold harmless the other Party, its respective affiliates, officers, agents, employees, and permitted successors and assigns against any and all claims, losses, damages, liabilities, penalties, punitive damages, expenses, reasonable legal fees and costs of any kind or amount whatsoever, which result from the negligence of or breach of this Agreement by the indemnifying party, its respective successors and assigns that occurs in connection with this Agreement. This section remains in full force and effect even after termination of the Agreement by its natural termination or the early termination by either party.
- **Limitation of Liability.** Under no circumstances will either party be liable to the other party or any third party for any damages resulting from any part of this agreement such as, but not limited to, loss of revenue or anticipated profit or lost business, costs of delay or failure of delivery, which are not related to or the direct result of a party's negligence or breach.
- **Entire Agreement.** The Parties acknowledge and agree that this Agreement represents the entire agreement between the Parties. In the event that the Parties desire to change, add, or otherwise modify any terms, they shall do so in writing to be signed by both parties.
